B. Supervisor Goral presented the 2014-2015 Budget Meeting Schedule.

C. Supervisor Goral presented the Annual Town Tax Levy for the 2013 year as follows: The Town Fund Levy at \$1,658,105.79 and the General Assistance Fund at \$808,171.41. The 2013 Levy represents a reduction of 4.33%. Trustee Tuite moved to approve the Annual Town Tax Levy as presented. Seconded by Trustee Staaf. The motion passed unanimously.

Deputy Highway Commissioner Trent presented the Annual Tax Levy for Road Purposes for the 2013 year as follows: Road and Bridge Fund at \$2,363,623.97 and the Road and Bridge Retirement Fund at \$124,401.26.
